Fire Walk Terms and Conditions

These terms and conditions ('the terms and conditions') apply to the Fire Walk taking place on Saturday 4th November at Irthlingborough Cricket Club ('the event').

By registering for and attending the event you are agreeing to these terms and conditions.

Participants

The event is open to anyone aged 18 and over. All participants must register prior to the event and pay the entry fee. Only registered participants will be allowed to take part in the event.

Entries are non-transferable and non-refundable.

In the event of the date or venue of the event being changed, or the event being cancelled, participants will be eligible for a refund. In these circumstances you can choose to transfer your entry to the alternative event (if applicable), donate the entry fee to the branch, or claim a refund.

Spectators

Spectators are welcome to attend to enjoy the food vendors and entertainment, as well as watching participants take place.

Certain areas of the event will be restricted to participants only and the branch reserves the right to further restrict access to the event (or certain areas of the event) in the interests of health and safety.

Timings

Participants are asked to arrive at 7.00pm ready for a briefing at 7.30pm. The firewalk is scheduled to begin at 8.15pm.

Due to the nature of the event, we can not guarantee the start time of individual participants and the exact timings of the event are subject to change.

Conduct

All participants and spectators must abide by the terms and conditions of the event, as well as any rules or instructions issued by agents of the branch, the Fundraising Fire Walk Association or any other event officials.

Participants must refrain from taking drugs, and consuming alcohol prior to the event. Any person who is, in the opinion of the branch or the Fundraising Fire Walk Association, unfit to take part will not be allowed to participate.

As this is a family friendly event, we ask that all participants and spectators refrain from using aggressive or abusive language during the course of the event.

Participants and spectators should also refrain from behaving in a way that that may cause injury or harm, which may cause offence or damage the reputation of the branch and our event partners.

All participants must ensure that their feet are clean and free from massage and pedicure oils. Nail varnish and toe rings are permitted.

The branch reserves the right to ask participants and supporters to leave the event if they do not adhere to these terms and conditions, or any instructions given at the event. No refunds shall be given in these circumstances.

Health and Safety

Participants are responsible for ensuring that they are sufficiently fit and healthy to take part in the event. Any participant unsure of their ability to take part in the event must seek medical advice from their GP prior to the event.

The branch reserves the right to refuse entry, at its sole discretion, with no refund provided, to any person considered to be unfit to take part.

It is important that participants drink plenty of water and are well hydrated prior to the event.

The branch and its event partners will take all reasonable steps to minimise the risk of injury to participants during the event. A risk assessment has been conducted which aims to minimise or eliminate any risk.

By taking part in the event participants recognise and accept that there may be circumstances or conditions beyond the branch's control that could lead to unforeseen risks.

Sponsorship

RSPCA Northamptonshire relies on the generosity of the local community to continue rehabilitating and rehoming hundreds of animals from across the county each year. We ask each participant to pledge to raise at least £100 for the branch.

Participants have a legal responsibility to ensure that all sponsorship received in connection with the event is paid to the branch as soon as possible. It is expected that all monies will be received by the branch within 6 weeks of the event.

Data Protection

When you register for the event we will collect personal information relating to you and anyone else that you register. We will use this information for the purpose of organising and running the event.

Following your registration we will contact you with information about your event, including to discuss your fundraising.

In the case of an emergency, we may also pass your personal information to the emergency services of healthcare professionals. We may also use them to contact your emergency contact.

Subject to your marketing preferences, we may also use your personal information for the purpose of sending you updates about the work of the branch and how you further support us.

All personal information will be handled in accordance with applicable laws and the branch's privacy statement.

Filming and Photography

The branch or our event partners may film or photograph participants, spectators and volunteers taking part in or attending the event.

Footage and photographs may be used for the branch to publicise future events, the work of the branch or fundraising more generally. This includes, but is not limited to, social media, advertising, publications, marketing materials and other documents.

Our event partners may also use the photographs and footage for the purpose of promoting their activities.

If you do not wish to be included in photographs and videography, you must inform the branch prior to the event so that we can organise excluding you from any photographs or videos.

Liability

All participants, volunteers and spectators attend and enter the event at their own risk. The branch shall not be liable for any loss, damage or injury to persons or their property that might occur as a result of the event other than any injury or loss arising as a result of our negligence.

For the avoidance of doubt, nothing in this clause shall limit our liability for any other liability that cannot be restricted or excluded by law.
